## FITTING INSTRUCTIONS

- To fit the radiator guard to the bike, cut the foam strips provided into 10mm wide pieces and stick them to the back of the radiator guard frame.
- Loosen the bolt (shown in picture 1), on the left and right-hand side, and gently pull the plastic covers away from the radiator, to allow 5mm clearance (shown in picture 2).
- Offer the radiator guard into position, ensuring the two mounting tabs sit over the bolts, and secure in place by tightening the two bolts back up.



- Pour monter la grille de protection radiateur sur la moto, couper la mousse en bandeaux de 10mm puis collez les au bas du cadre de protection radiateur
- Desserrer le boulon (voir photo 1), du côté gauche et du côté droit puis tirer les caches plastique du radiateur, pour laisser 5mm d'espace (voir photo 2).
- Monter la grille de protection en position, en veillant à ce que les 2 onglets de montage se placent sur les boulons, puis fixez la en place en serrant les 2 boulons.

- Um den Kühlerschutz am Motorrad zu montieren, schneiden Sie zuerst die mitgelieferten Schaumstoffstreifen in 10 mm breite Streifen und kleben Sie diese auf der Rückseite des Kühlerschutzrahmens.
- Lösen Sie die Schraube (siehe Abbildung 1) an der linken und rechten Seite, und vorsichtig die Kunststoffabdeckungen vom Kühler wegziehen, um 5mm Zwischenraum zu bekommen (siehe Abbildung 2).
- Den Kühlerschutz in Position bringen. Bitte darauf achten, dass die zwei Montagelaschen über den Schrauben positioniert sind, dann befestigen Sie den Kühlerschutz, indem Sie die Schrauben wieder anziehen.
