

FITTING INSTRUCTIONS FOR SBP0006 SPINDLE BLANKING PLATES BMW R1200RS 2015-



THIS KIT CONTAINS THE ITEMS PICTURED AND LABELLED BELOW. DO NOT PROCEED UNTIL YOU ARE SURE ALL PARTS ARE PRESENT.

Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike

Please note that in cases where kits are packed with a plastic tube separating components on the spindle bar (this tube should be discarded).

FITTING INSTRUCTIONS

- Remove the plastic dust cover that sits over the rear wheel spindle in the swingarm. Using a small/thin screwdriver or similar, gently ease the cover out from the outer edge, as shown in the pictures above.
- Fit one nut and washer on spindle-bar (SB104) (the end with shorter thread), engage the nut so the plastic insert of nut is fully engaged.
- Feed spindle-bar with nut and washer through the larger spindle cap (S0905).
- Place this assembly through the rear wheel spindle from the left hand side, ensuring the groove on the rear of the metal spindle cap fits over the exposed end of the rear wheel spindle.
- With the spindle bar protruding from the right side of the bike, position the smaller spindle cap (SC0003) over the exposed thread, ensuring it locates onto the rear wheel spindle and fit the remaining washer and nyloc nut.
- Tighten both nuts ensuring both are engaged in nylon and equal amounts protrude from either side (please ensure the logo is located at the top of the crash protector). Do not overtighten the nyloc nuts will hold it tight.





Instructions de montage:

- Retirez le couvercle de protection en plastique qui est placé autour de l'axe de roue arrière dans le bras oscillant, avec un petit tournevis et retirer doucement la protection du bord extérieur, comme indiqué sur les photos ci dessus.
- Insérer un écrou et une rondelle sur l'axe (SB104) (l'extrémité avec le filetage le plus court), en engager l'écrou de façon à ce que l'insert en plastique soit complètement engagé.
- Passer l'axe avec écrou et rondelle à travers le capuchon d'axe le plus large (S0905).
- Placer cet ensemble à travers l'axe de roue arrière depuis le coté gauche, en vous assurant que la rainure à l'arrière du capuchon d'axe en métal se place bien autour de l'axe de roue arrière.
- Une fois l'axe dépassant du coté droit de la moto, positionnez le petit capuchon d'axe (SC0003) autour de l'extrémité, en vous assurant qu'il se place bien sur l'axe de roue arrière et insérer la rondelle restante et l'écrou en Nyloc.
- Serrer les 2 écrous, en vous assurant que les 2 soient bien engagés dans le nylon et que les longueurs dépassants de chaque coté soient égales (assurez vous également que le logo R&G soit placé sur le haut de la protection). NE PAS TROP SERRER – les écrous de Nyloc fixent l'ensemble.
