



FITTING INSTRUCTIONS FOR R&G LICENCE PLATE HANGER

CAGIVA MITO 125 (part code LP0046K)



- Remove both seats
- Disconnect wiring to original light unit
- Remove rear seat cowling
- Undo the 4 bolts holding the original number plate unit to the bike (2 from side, 2 from rear)
- Remove OEM indicators from original unit
- Fit OEM or after-market indicators to new tail-tidy (R&G product code RG370)
- If using OEM indicators secure as original
- If using after-market indicators fit as instructed
- Offer new tail-tidy unit up and using new spacers and button head screws with washers supplied in kit secure tail-tidy to rear frame, using original nuts and bolts secure indicator flanges from sides
- Feed indicator wires through original routing
- **IMPORTANT: IF FITTING A FULL-SIZE LICENCE PLATE AND PLACING IT FAR DOWN ON THE LICENCE PLATE HANGER, THERE IS A SMALL CHANCE OF THE LICENCE PLATE HITTING THE BACK WHEEL UNDER HEAVY LOAD AND OVER LARGE BUMPS IN THE ROAD. IT IS YOUR RESPONSIBILITY TO CHECK FOR THIS POSSIBILITY AND TAKE AVOIDING ACTION. FAILURE TO CHECK THIS COULD RESULT IN SERIOUS INJURY.**
- Recheck that all bolts/screws are tight and wiring is safe and tidy
- Refit rear cowling
- Refit seats
- Depending on local laws, attach enclosed red reflective tape in an appropriate location
- Test the indicators and licence plate illuminator before riding

These terms do not affect the Buyer's statutory rights.

R&G RACING RETURNS POLICY (NON-FAULTY GOODS)

Returns must be pre-authorized (if not pre-authorized the return will be rejected). Goods may only be returned direct to us if they were purchased direct from us (customer must prove if necessary). Otherwise to be returned to original vendor. Goods must be in resellable condition, in the opinion of R&G Racing. All returns are subject to a 25% restocking and handling fee (25% of the gross value exc. P&P – at the prevailing price at time of purchase). The customer must pay any and all carriage charges. No returns of discontinued products, unless within 14 days of purchase. This policy does not affect your statutory rights and does not refer to faulty goods.
