

TOOLS REQUIRED

• Socket set to include 2x 13 sockets and wrenches

FITTING INSTRUCTIONS

- Fit the spacer with the larger spigot into the hexagon shaped recess in right hand side of front spindle.
- Fit one nut and washer on spindle-bar (the end with shorter thread), engage the nut so the plastic insert of nut is fully engaged.
- Feed spindle-bar with nut and washer through either bobbin and through spindle spacer (from the right hand side) just fitted.
- Place remaining spacer with smaller spigot over exposed left hand end of spindle-bar so the smaller spigot locates in left hand side of spindle.
- Fit washer and nut from kit onto thread and tighten until both nuts are engaged in nylon and equal amounts protrude from either side. Do not overtighten the nyloc nuts will hold it tight.



Instructions de montage

- Passer l'entretoise avec le plus gros axe dans l'évidement de forme hexagonale du coté droit à l'avant de l'axe.
- Passer un écrou et rondelle sur l'axe (l'extrémité avec le filetage le plus court), engager l'écrou de sorte à ce que l'insert en plastique de l'écrou soit bien engagé.
- Passer l'axe avec ecrou et rondelle à travers l'une des bobines et à travers l'entretoise de l'axe (coté droit) tout juste installée.
- Placer l'entretoise restante avec le plus petit axe autour de l'extrémité coté gauche de l'axe de sorte à ce que l'axe se situe du coté gauche de l'axe.
- Passer rondelle et écrou du kit sur le filetage puis serrer jusqu'à ce que les 2 écrous soient serrés dans le Nylon et faire attention à ce que la même longueur dépasse de chaque coté. Ne pas trop serrer les écrous en Nyloc feront tenir l'ensemble.
