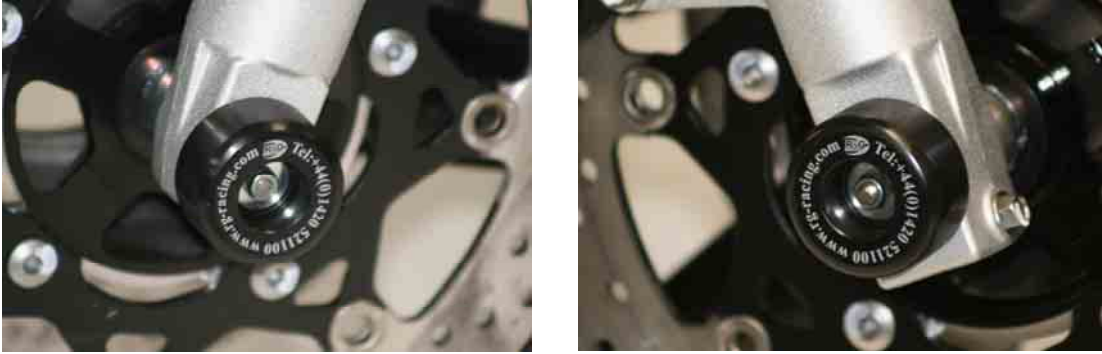




FITTING INSTRUCTIONS FOR FP0077BK FORK PROTECTORS SUZUKI GSX 1400



Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike

Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – *the rubber washers should be thrown away!*

Left-hand side (as you sit on bike)

- Place bobbin with the larger neck into left hand side of front spindle so spigot fits into spindle, (it may be a snug fit so may require light tap with soft mallet or palm of hand).
- Fit nyloc nut and washer from kit onto spindle bar from kit tighten until the nut comes into contact with plastic gripper on nut.
- Feed spindle bar assembly through bobbin (just positioned) and front wheel spindle.

Right-hand side (as you sit on bike)

- Place bobbin with the smaller neck over protruding bar and into right hand side of front spindle so that the neck locates into hole in spindle.
- Fit washer and nyloc nut to bar and tighten the assembly - Do not overtighten – the nyloc nuts will hold it tight.

Other than identified above and subject to R&G not limiting its liability for causing death and personal injury, it shall not be



liable for indirect or consequential loss and otherwise its liability shall be limited to the amounts paid by the Buyer for the Products or the fitting or service concerned. These terms do not affect the Buyer's statutory rights.

R&G RACING RETURNS POLICY (NON-FAULTY GOODS)

Returns must be pre-authorized (if not pre-authorized the return will be rejected). Goods may only be returned direct to us if they were purchased direct from us (customer must prove if necessary). Otherwise to be returned to original vendor. Goods must be in resellable condition, in the opinion of R&G Racing. All returns are subject to a 25% restocking and handling fee (25% of the gross value exc. P&P – at the prevailing price at time of purchase). The customer must pay any and all carriage charges. No returns of discontinued products, unless within 14 days of purchase. This policy does not affect your statutory rights and does not refer to faulty goods.
